**AUDITOR'S REPORT**


- 1) I have examined the Balance Sheet as on 31.03.2017, and the Income and Expenditure Account for the period beginning from 01.04.2016 to ending on 31.03.2017, attached herewith, of Nagar Palika, Shahjahanpur.
- 2) I certify that the Balance Sheet and the Income and Expenditure Account are in agreement with the books of account maintained at the Nagar Palika, Shahjahanpur.
- 3) (a) I report the following observations/comments/discrepancies/inconsistencies:
  1. Tax Revenue consist of Property Tax, Water Tax, Severage Tax, Water Price, Entertainment Tax, Animal Tax, Advertisement Tax and Other Tax are base on information provided by the tax department of Nagar Palika Shahjahanpur.
  2. Provision of VAT partly Compliance as per VAT Act 2008 in the year 2016-17 .
  3. The provision of TCS/ TDS partly Compliance as per Income Tax Act, 1961 in the year 2016-17.
  4. The Nagar Palika Shahjahanpur is Local Authority and subject to audit report of AG, Allahabad . The Report of AG observed by us and in our opinion audit objections of AG Report are partly compliance by Nagar Palika Shahjahanpur.
  5. Further in our opinion Internal Control System of Nagar Palika Shahjahanpur is required to more attention by management of Nagar Palika Shahjahanpur adequate as per AG report.
  6. No grant register was provided to us for verification of given figure in balance sheet.
  7. The Provisioning of Tax Revenue of Nagar Palika Shahjahanpur is increasing by 10% during the year, but no steps has been taken to collect such Tax, due to which balances of these accounts are increasing every year.
  8. Opening and closing stock is being carry forwarded from the last 8 years.
  9. Statutory liabilities of PF, Income Tax , Service Tax and VAT have not been timely deposited on due dates, proper details to ascertain the quantum of such liabilities could not be provided to us.
  10. Proper party wise details Liabilities outstanding of Contractors and others are not available.


11. Fixed Assets register has not been maintained. Details of Assets were compiled on the basis of information received.
12. Sundry Debtors (Receivables) value shown in balance sheet is as per details provided by Computer Section.
13. Some Bank Accounts are showing negative balances due to improper reconciliation. Besides rectification old outstanding entries in BRS prepared have not been passed in Book of Accounts.
14. Security Deposit received from contractors and other third parties is as per records received, but no individual party wise list was available.
15. Details of Property Tax received are subject to reconciliation.

(b) Subject to above —

- a) have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of the audit.
- b) In my opinion, proper books of account have been kept by the head office so far as appears from my examination of the books.
- c) In my opinion and to the best of my information and according to the explanations given to me, the said accounts, read with notes thereon, if any give a true and fair view:-
  - i. in the case of the Balance Sheet, the state of the affairs of the Nagar Palika Shahjahanpur, as at 31.03.2018; and
  - ii. in the case of Income and Expenditure Account of the Nagar Palika Shahjahanpur for the year ended on that date 31.03.2018;
  - iii. in the case of Receipts & payments Accounts and of the Nagar Palika Shahjahanpur for the year ended on that date 31.03:2018.
